You're invited to a special general assembly (see calendar below) where you'll be consulted on the demands you think the APTS should put forward during the contract talks for your next provincial collective agreement.

When health and social services minister, Christian Dubé unveiled his recent plan to reform the health system, he said that changes are needed to make our system more human and help it perform more effectively. He said he was committed to making the public health and social services system into “an employer of choice.”

For these changes to occur, we have to negotiate better pay and better working conditions for you, and that's the process we're initiating with this consultation. We need your help to carry it through – your participation is crucial at every stage of the process. APTS provincial contract talks belong to you.

The consultation workbooks attached to this notice of meeting are intended as a basis for discussion. Thanks to your responses and comments, we'll be able to improve our project.
